CODE OF ETHICS

- Coaches, guardians and players shall not cause or incite disturbance by loud or frequent disagreements with game officials and/or coaching judgments or decisions.
- The coach, an official, the director or commissioner of an AMA sport may warn or have anyone removed from an AMA function who acts in an unsportsmanlike manner.
- Any player/coach in violation of being unsafe, verbally or physically abusive, or any other unsportsmanlike behavior. shall be subject to the disciplinary action of head coach, director or commissioner of an AMA sport.
- The commissioner of an AMA sport will address any action that is deemed unacceptable by head coach. The commissioner may then take appropriate action to insure that this violation will not be repeated.
- The director of an AMA sport will address any action that is deemed unacceptable by the commissioner of an AMA sport. The director of that AMA sport may then take action to ensure that this violation will not be repeated.

NOTES

- Playing positions and the amount of playtime is determined by the coaching staff based upon the overall needs of the team, individual ability and effort.
- o Every effort will be made to give each player an opportunity to learn and grow as well as to have a good season for the overall team.
- The coaching staff is happy to address any parental concerns and guestions, provided that games or practices are not interrupted and shall be addressed before or after practice or via phone. Discussions may not take place during or immediately following games and/or in front of players.
